- B. USPA/Competition Committee will provide at cost the required Team Uniform to the U.S. Team. Other team clothing will be at the discretion of the Team Manager.
- C. Sponsorship/Advertising on the uniform will be limited to the right sleeve between the shoulder and elbow limited to 8 inches high and 4 inches wide.
- D. Sponsorship/Advertising on any team uniform or clothing must be appropriate and bring no discredit to the U.S.
- 11-1.5.B add after Team personnel “to include Head of delegation, Team Manager, Coach and Competition personnel”
- 11-4.18 add at end “and event organizer”
- Policy on team trophies won at International events, where do they go
