5.5.3 Reverse order of standing shall be recalculated at the completion of the first round and may be recalculated again at the completion of the second round, at the discretion of the Meet Director Chief Judge.. This order will determine the exit order for the following tasks.

6.4.5 The starting order of the first round of jumping shall be in reverse order of the standings at the most recent USPA Nationals. Teams that did not participate in the most recent USPA Nationals will jump at the beginning of the round with the order determined by random draw made by the Meet Director Chief Judge..

5.1. Order of Jumping

5.1.1 The starting order of the first round shall be in reverse order of the standings at the most recent USPA Nationals. Competitors that did not participate in the most recent USPA Nationals will jump at the beginning of the task with the order determined by a random draw made by the Meet Director. Chief Judge.

b. Adopt SIM guidance for competition jumps – SIM 5-11 E- Speed Skydivers exit 1^{st}

OLD SIM 6-13 E – May be reworded in 5-11 E

1. Exit and freefall

a. Exit order primarily depends on the speed consistently attained. Once a speed skydiving can demonstrate that they are consistently exceeding normal max free-fly speeds (in excess of approximately 250 mph), speed skydivers who are training should be allowed to exit first and instructed to turn away from jump run. Trained speed skydivers exiting after other jumps is an extreme safety risk. A speed skydiver traveling 300 mph that collides with a solo belly jumper in a baggy suit will have a 200-mph closure rate. With multiple speed skydivers, exit order should be fastest out first, with consideration given to deployment altitudes and parachute type/size if necessary.
